TYPE OF SCHOLARSHIP: ENDOWMENT vs CURRENT USE

If you wish to make annual gifts to support a scholarship you may establish a current use fund, an annually funded scholarship. The money is awarded each year to a student who meets the established scholarship criteria. A multi-year commitment is required for current use scholarships.

If you would like to make a permanent commitment to support a scholarship you may establish an endowed fund. An endowed fund is invested and the interest earned from the principal provides the annual distribution to support a scholarship in perpetuity. The minimum amount for a named endowed scholarship fund is \$100,000 and may be reached over a period of five years.

SCHOLARSHIP CUSTOMIZATION

Scholarships may be customized based on a donor's philanthropic passions. There are multiple criteria that a prospective donor may choose to incorporate when creating their scholarship description. Development officers can assist donors in choosing criteria that fits their interests.

In addition, the College of Veterinary Medicine, in consultation with university partners (Student Financial Aid, Office of Legal Services) will verify that the criteria are not too restrictive and ensure they are legal, applicable and practical to administer now and in the future.

Donors cannot be involved in the selection of the recipients of their scholarships as this would jeopardize the charitable status of their contributions.

SCHOLARSHIP STEWARDSHIP

The College of Veterinary Medicine will provide the donor with annual updates on the status of their current use or endowed scholarship. In addition, the college will extend an invitation to donors and recipients to attend its popular Evening of Gratitude dinner, a special occasion that brings together donors to celebrate the power of philanthropy.
